



Estex Awards Terms & Conditions

This competition is organized by Estex Awards. Those electing to submit works for consideration are defined throughout this document as “Applicants” to include individuals and teams.

Except where indicated otherwise, all copyright and other rights that subsist in the home page and in the sub-domain pages of the estexawards.com website are owned by Estex Awards.

Entry is void where prohibited by law.

By submitting entries to the competition you assent that you have read and agree to abide by these terms and conditions.

Eligibility

The Competition is open to real estate agents with an active license in the USA who are in good standing with their real estate commission.

Estex Membership is not required to enter. Applicant must be 18 years of age or older.

Individuals or teams are eligible to enter and acknowledge that there is one set of criteria for individuals and another set of criteria for teams.

Employees of Estex Awards or members of their households are not eligible to enter. Estex reserves the right to disqualify you if it has reasonable grounds to believe that you have breached any of the terms. Entry fees will not be refunded.

Entries

All entries shall become the property of Estex and will not be returned. All applicants agree that they have read the criteria for receiving an award (available on estexawards.com) before registering and making payment for the award.

Applicants must submit a broker recommendation form to be eligible for the award.

Applicants must complete the entry form and pay the required entry fee. If payment is not received, the submission will be deemed ineligible and will not be judged.

The entry fee is non-refundable regardless of whether or not the entry is submitted. Changes can not be made after the entry has been submitted to judges.

Your Entry and any supporting documentation and materials provided to us will not be considered to be Confidential Information unless you mark any specific information contained within the entry as confidential. You may not mark your entire Entry as Confidential Information.

In circumstances where a Participant's work is not eligible for the Awards for any reason, Estex Awards will inform the Participant who submitted the entry in a timely manner with the reason for disqualification. You may not appeal any decision made by us that an Entry is a Non-compliant Entry and we shall not be liable for any losses, actions, costs (including legal fees and disbursements on a solicitor/client basis), claims, demands, fines, damages and liabilities, of whatever nature, incurred or suffered by you (including any loss of goodwill, loss of profits and loss of revenue)

in connection with: (i) the disqualification of an Entry (including in circumstances where such disqualification results in the withdrawal of an award awarded to you in an Awards Competition and including in relation to any loss of goodwill or damage to reputation caused by such disqualification); or (ii) any publicity related to such disqualification, including any announcement or communication that we may choose to make (in our absolute discretion) in connection with our decision to disqualify the relevant Entry.

Entries will not be accepted via email or other channels unless officially announced via the Estex Awards website.

We will not accept responsibility for Entries that are lost, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind, or other causes outside our reasonable control.

Entries that are not submitted by the deadline will not be considered and refunds will not be issued.

Applicants must not submit any Entry that you know or suspect:

(i) is inaccurate, false, or misleading (including where it omits material information regarding the subject of the Entry); and/or

(ii) contains information or material that: (a) infringes the intellectual property rights of any third party; (b) the disclosure of which would place you in breach of confidentiality obligations owed by you to any third party; or (c) is or may be defamatory.

Applicants agree to:

(ii) Read all email correspondence from us promptly and respond as requested or required

Applicants cannot use false contact information details or identifying details, impersonating any person in order to mislead.

Timeline

These dates may be subject to change but upon launch, the timeline is: Entries open January 1, 2024.

Deadline for entry submission is May 31, 2024 . Entries must be completed and submitted on or before this date.

Award winners will be announced on our website on or before September 30, 2024.

Judging

Completing and submitting an application does not mean an entrant will receive an award.

A judge will evaluate the submission and determine award eligibility. The identity of the judges may or may not be revealed.

A judge will award points to entries based on information provided in the entry and make a determination of whether or not an award will be given to the entrant. Applicants acknowledge that some of the judging criteria is subjective, and the judge will determine the number of points received. The decision of the judge is final and will prevail. We will not enter into any correspondence or discussion with any entrants nor will we accept any submissions, representations or appeals with regard to such decision.

The Award

Award winners will be announced on estexawards.com on or before September 30, 2024. Award winners will receive a digital award graphic. If this graphic is not received by the winning Applicant by email on or before October 14, 2024, it is the responsibility of the applicant to contact Estex Awards at info@estexawards.com to request information on where the digital award can be downloaded.
